

Frequently Asked Questions

What is ShareCare?

ShareCare is a local program available in the Duluth MN/Superior WI area that offers a reduced rate of payment for health care services based on one's household income. Those eligible for ShareCare are issued a card which indicates the percentage of payment required. The ShareCare card is currently accepted at 41 health care sites (see pages 3-4). The program is administered by Generations Health Care Initiatives and supported by St. Luke's, Integrity Health Network, Duluth Family Practice Center, Lake Superior Community Health Center and several other private health care organizations.

Who is eligible for ShareCare?

Individuals and families are eligible if they: 1) Have no health insurance, 2) Are not eligible for other public programs and 3) Meet income eligibility criteria that is at or below to 300% of the federal poverty guidelines.

How much will I pay?

Your percent reduction from charges will vary from 0-100%, depending on your household size and income level.

What information do I need to bring when I apply?

- Social security numbers for household members
- Copies of paycheck stubs
- Statements with amount of other income sources
- Bank account information
- If self-employed, copy of most recent tax return

Will I have access to preventative and wellness care?

Yes, other medical specialist participating in ShareCare place a strong emphasis on preventive and wellness care for you and your family. During enrollment, you will be asked to choose one participating clinic or doctor as your health care home. When necessary, you may see other medical specialists within the ShareCare network.

What type of health care services are covered?

- Clinic physician services, both primary care and specialty care
- Immunizations
- Lab and X-ray
- Inpatient and outpatient hospital care
- Urgent care
- Emergency room services when used for a true emergency
- Physical, Occupational, Speech, Respiratory, and Rehabilitative Therapy
- Home health services
- Hospice care
- Eye and hearing exams

Is there any type of care that is not covered?

- Prescription drugs from retail pharmacies (including those operated by the participating health care organizations)
- Medical equipment and supplies
- Eye glasses
- Hearing aids
- Prosthetics
- Ambulance and transportation services
- Cosmetic services
- Chiropractic care
- Dental care
- Alcohol and drug treatment
- Autopsy
- Treatment for infertility
- Services that are not deemed medically necessary
- Services received before the effective enrollment date or after the termination date in this program

The Health Care Access Office staff is also knowledgeable about other health programs that cover health needs such as medications, eyeglasses and dental care.
