

YEAR IN REVIEW

2019-2020



The year 2020 may well be remembered as one of the most challenging years on record. The COVID-19 pandemic and the ensuing economic shutdown created widespread unemployment and millions of newly uninsured patients, straining healthcare infrastructure. As a critical component in the regional continuum of healthcare, Lake Superior Community Health Center continues to play an integral role in caring for the entire community - from the most well-off among us, to our most vulnerable and underserved friends and neighbors. For nearly 50 years, our mission has not changed: LSCHC will be a reliable source for healthcare and innovation in the communities we serve, ensuring that everyone who chooses LSCHC has access to the high quality care we provide.

But our mission isn't just about having a presence in the community. Adaptation and resiliency are fundamental to the community health movement, and our ability to adjust our model to fill gaps in the provision of care for our community remains one of our biggest strengths. In March, as the trajectory of COVID-19 became more and more apparent, LSCHC went to work preparing for the inevitable changes needed to serve an increasingly quarantined and otherwise isolated population. In a matter of weeks, virtual care options were implemented to ensure we can continue serving patients without requiring a physical visit to the clinic. Today, all of our services can be made available to our patients via telehealth.

Further, new protocols and practices have been put in place to ensure that the patients who do come into the clinic are as safe as possible. We are committed to joining others in the community in slowing the spread of this disease. For example, we purchased climate-controlled outbuildings to isolate patients in need of COVID testing, greeters were hired to screen patients entering the building, and we are actively participating in community as well as internal strategic activities to ensure continual improvement in activities related to mitigation.

Amid the ongoing fight to control a pandemic, LSCHC has found opportunities to expand access to both new and existing service lines. In June, we opened our first chiropractic practice on Grand Avenue. We are fortunate to have a veteran community chiropractor, Dr. Kara McGillivray, providing exceptional care at this site. The addition of chiropractic services adds to the integrated offerings already available, particularly to patients with acute or chronic pain.

We also recently expanded into a new county when we opened a dental practice in Carlton, MN. The addition of the Carlton practice brings much needed access to oral health services to community members with Medicaid or no insurance. While we are happy to serve all patients, including those with private insurance, we are delighted to be talking with community leaders about how we can address additional gaps in community care. For example, the community might benefit from additional behavioral health services, so we are gathering needs based information from community leaders and community members to determine how and when we might expand other services in Carlton.

Today, community health centers are working harder than ever to ensure the affordable provision of quality care. Collectively, the 1,400 centers that make up the community health center network serve over 30 million patients — one in 12 people nationwide. We take pride in our comprehensive, integrated approach to care - an approach that is best practice in producing quality outcomes and for meeting patients' needs. Thank you for your ongoing support of LSCHC. Your support makes the work we do possible. Thank you.



COVID RELIEF FOR LOCAL EMERGENCY ROOMS

In light of the COVID-19 pandemic and the resulting increase in demand for emergency services in the region, LSCHC expanded access to emergency dental services. Partnerships have been created with local emergency rooms to ensure patients showing up to the ER with dental pain or other dental issues can be easily referred to available emergency appointments at LSCHC practices. This helps take the pressure off local ERs as they work day and night to combat COVID, and allows us to do one of the things we do best — provide high quality, integrated oral health services to residents of Duluth, Superior and the surrounding region.

% OF PATIENTS BY SERVICE LINE






RACE/ETHNICITY GRAPH

INCOME GRAPH




Above 200% federal poverty guideline – 10.36%

Uninsured – 22.02%




Total Revenue \$10,375,770
